LIFE MEMBERSHIP – Nomination Form

CRITERIA

- Nominee must have a minimum of ten years of consecutive membership.
- During the membership period, the nominee must have given five years of exceptional service.
- The nominee must be a financial member of the club at the time of nomination and ratification.

PROCESS

- Nominations must be made in writing by a financial member of the club
- Nominations must be received by the Club Secretary no later than 15 June of each year. Send to Secretary@knoxodc.org.au
- If approved by committee, nominees will be printed in the October newsletter (or similar) each year
- Any objections to Committee approved nominees printed in the October Newsletter must be made in writing to the committee and received before 31 October of the year of publication
- Nominees will be ratified at the Annual General Meeting of the Club

OTHER NOTES

- Life membership should be considered an honour bestowed upon a member of the club for service that goes beyond that of other volunteers
- The service should be sacrificial in nature and not directly for personal status, kudos or gain
- The nomination form should contain enough information, with examples where applicable, which demonstrates why the contribution from the nominee is considered exceptional. If the Committee decides it requires further information to consider the nomination, the person proposing the nomination maybe asked to attend the July Committee meeting to provide such information.
- The nomination may include reference to:
 - A significant contribution
 - General achievements which have had a positive effect at/on the club
 - Achievements that have demonstrated the nominee to be an outstanding representative of the club
 - Commitment of the individual
- The character, personal standing and behaviour of the nominee shall be beyond reproach
- Meeting the criteria does not automatically entitle a member to Life Membership
- Nominations are to be kept confidential until such time as those passed by the Committee are printed in the October newsletter (or similar) each year
